In 1990, there existed four training venues and three meeting points and the above personnel were instrumental in providing encouragement and advise at all these places. The N.S.W. State Director of Umpires provided much assistance and advise to promote the professional development and progress of our Membership.

The Officers and staff of the N.S.W. Australian Football League continued the cordial and friendly relationships that have existed between our two bodies over the years. We are in debt for their support and counsel. The Protests and Disputes Committee have given their

support to football in Sydney by penalising serious transgressions by a limited number of players. Football umpiring can only but improve with the support staff that this Association regularly deals with. To all and sundry, thank you for your assistance and we look forward to working with you next year.

I would like to congratulate the many Members who have attained significant successes last year. Naturally, to our two new Life Members, Max and Danny, whose past efforts for the Association was unanimously endorsed at the Annual General Meeting. To everyone who gained a Grand Final appointment, congratulations for what was the culmination of a seasons endeavour and, I believe, a memorable series of games. The selection to A.F.L. competition games is a remarkable effort when one acknowledges that Australian Football in this city is not the major winter code, and that those Members did not let their Association down. To the many Members who earnt representative games, congratulations and well done. Many people contributed in many ways to make this year so successful. This camaraderie has enabled your Association to begin the new decade in a positive way. It is important that progress is not stymied, but further accelerated such that everyone reaches their potential.

Secretary's Report

The 1990 Season needed to be one of consolidation after the fall off of numbers during 1989 and it started with the appointment of three experienced men to control the destiny of Sydney Umpiring. After a long career as a Field/Boundary Umpire, Max Henry was appointed Umpires Coach; similarly Danny Daniel, after many years as a senior Goal Umpire, was given the job of overseeing the Goal Umpires and John Reid, after a two year break, resumed as Fitness Coach.

There is no doubt that the selection of these three gentlemen was a positive step towards improving the standard of Sydney Umpiring. Whilst numbers did not have a large increase, with the Association still unable to fill all appointments, the depth of the senior panel was strong and several novice umpires started with the group and were quick to show their potential.

The enthusiasm of the squad was high and congratulations must go to Max, Danny and John for achieving a level of team spirit that made umpiring in 1990 very enjoyable.

Appointments

During the season several individual appointments were worthy of acknowledgment.

Martin Jackson acted as Emergency Umpire for the State of Origin match - N.S.W. versus Victoria.

The renamed AFL competition included a number of members performing at the top level, with Roger Crowhurst, Nick Angelos and Ken Ray making their debut. Whilst again these appointments affected the numbers available for the local competitions, umpires who achieve these rewards create opportunities for others to experience higher standards in the Sydney competitions and bring back with them from the AFL knowledge that is of great benefit to their umpiring.

Steve Arnott gained selection as the Sydney representative for the State Championships in Canberra and was described as the most consistent umpire on show during the carnival.

The NSW Country Championships saw Nick Angelos, David Yole, Joe Matchett and Paul Hoare represent the Association in elimination rounds, while Andrew Gibson, Lachlan Burnett and Lindsay Kain were

appointed to the Final with David Yole as emergency.

At a Junior level, Nick Angelos travelled to Brisbane for the Australian Schoolboys Championships and Dean Morters to Wagga for the Shell Cup trials.

To all these umpires and everyone who achieved their personal goals for 1990, congratulations.

Finals Series

Undoubtedly the 1990 Finals Series contained some of the best football seen in Sydney for many years. The standard of umpiring not only enhanced the football but ensured with strong control no repetitions of misbehaviour evidenced in other Leagues throughout Australia. In each division the best team in the competition won on Grand Final Day, congratulations to them and to the umpires listed later in this report for their performances not only on Grand Final day but throughout the season.

Board

It was pleasing to see three new faces on the Board in 1990. Brinley Sheppard joined as Social Director with a number of very successful social functions being organised. Roger Crowhurst was responsible for umpire problems and did a good job in being the link man between the Association and the UAB. Nick Angelos acted as Liason Officer between the NSW AFL and with some difficulties experienced in umpire payments, had a very busy job and was extremely diligent in that role. Any problem that did arise was quickly settled with the help of Craig Davis and Donna Burke. The relationship the Association has with the League is one the Association is proud of.

Unfortunately 1991 will be the first season in 13 years Mark Rendell will not be involved with the Board as he has decided to stand down from the Presidency. Mark has seen many changes in Sydney football since 1975 and his contribution towards Sydney umpiring is immeasurable. His guidance, direction support and co-operation will be sadly missed, however we will still have his skills as an umpire as he nears 300 games in first grade.

Umpires Appointments Board

The appointment of Max Henry and Danny Daniel, as described earlier, pointed Sydney umpiring towards a more professional approach and together with David Levens and Terry Godfrey formed a strong UAB. The time and effort these men put in organising appointments, observing, coaching, advising and general management, assisted everyone in the group. At AFL level, Geoff Dempsey's advice and encouragement was always welcome.

Fitness

As mentioned earlier, John Reid returned as Fitness Coach in 1990 and despite the year looking a repeat of 1989 as far as wet weather went, conducted programs that had every umpire fit enough to perform at their best. The improvement in 4 Km. times by every member of the group is clear evidence of the success of John's schedule.

Awards

The end of year awards list was extended in 1990 to try and capture not only the best in umpiring performance but to include encouragement to those endeavouring to improve and those who contribute beyond expectations to the Association.

9. The details of material transfers to or from reserves and/or provisions during the financial year were nil.

UMPIRES REPRESENTATIVE REPORT.

Fellow Members,

It was indeed with great pleasure and a certain amount of intrepidity when I was offered the opportunity to fill a vacancy on the Board of Directors earlier this year.

It was always considered that such positions were held by members who rated higher on the "popularity" than others. However, I welcomed the challenge the role of Umpires Representative presented to me.

The nature of the problems that were taken before your Board were various and included some of the following.

APPOINTMENTS.

The Association does not, nor should have any control over appointments. This is an area totally controlled by the Umpires Appointments Board (UAB). The role of your Association is to represent the Members and on several occasions Members did request assistance in seeking information from the UAB relating to their appointments. The UAB is only too happy to provide advice and guidance to Members and Members who do not wish to approach the UAB direct are encouraged to seek the assistance of your Association Executive.

TRIBUNAL

We experienced a few problems this year with the Tribunal. This mostly occurred with some of our younger Members, finding the Tribunal a demanding and stressful experience. Fortunately on most occasions the presence of senior umpires, on sitting nights was helpful to provide both advice and where necessary, advocacy. The Board is aware of this and when needed can arrange for suitable advocates to be made available. Your Board is also making submissions in relation to the sitting arrangements, with the hope of reducing the waiting and delay time that can be experienced at hearings.

This season has seen an excellent start to the 90's, and I congratulate all umpires who achieved their goals for the year. I would like to thank my fellow Board Members for their assistance and co-operation, and particularly Mark Rendell for his advice and guidance. My thanks goes also to David Levens, Max Henry and the UAB for their assistance that enabled me to carry out my function.

TRAINERS REPORT

I would like to take this opportunity to thank the following people for their assistance during 1990:

Pat Coward, Craig Davis, Peter Hampshire, Max Henry, David Levens, Brinley Sheppard and a special thank you to Mark Rendell for all their support.

For those interested a report is available which details the Sydney umpires training programme (including all 4km. time trials and handicap race results) from January through to September. The programme was based on slow and fast interval running as well as slow to fast distance runs. Interval training is running set distances with limited periods of rest between each effort.

It must be realised that the training programme is a diary only and various training sessions have been changed to fit the circumstances on a lot of occasions ie; because of ground closures due to rain and ovals being used by other groups etc... However, most of the training sessions could be expected to be used in 1991 with only minor variation.

A total of 79 umpires attended training during the year; the highest number on any one night during January was 21, February 23, March 27, April 33, May 39, June 34, July 39, August 32 and September 34.

The fitness level of the majority of umpires who umpired in 1989 and then attended training sessions during January and February was poor. It is apparent that most umpired in Sydney do not train at all in the off-season.

Due to the vast standard of fitness levels amongst the umpires, were broken up into 3-5 groups per night, depending on numbers. Each group then attempted to compete each sprint in the time allocated. Even in some groups there was a big difference between the top athlete and the bottom.

Each group on average achieved the times allocated, which was great. The peer pressure within the groups for all umpires to finish the training session was very good. There was plenty of encouragement from umpires within each group for others to strive to complete the training session and then to finish in the time allotted. If this same attitude is displayed in 1991 and I am sure it will, then we can all look forward to a great season in 1991 on the training track.

Sponsorship was arranged for the best performers at training each week. Kallis and French were the sponsors and provided seafood each week. Many thanks to Tony St.Clair in providing these awards. To receive these awards the umpire had to attend both nights in the week.

The top weekly performers were T. Haughan, D. Galloway, P. Rowan, S. Wallbank, S. Arnott, D. Morters, S. Burdack, D. James, S. Ardill, M. Jackson, C. Dimolianis, F. Kalayzich, P. Hampshire, R. Crowhurst, A. Norris, K. Radley, B. Sheppard, D. Yole and K. Ray.

A handicap race was also arranged for each month with trays of seafood for the first three across the line and the fastest time. These weekly training awards created great interest and appeared to have a positive effect on most umpires regarding training.

Handicap winners were M. Abrahams, S. Arnott, D. Galloway, S. Wallbank, N. Myatt and T. Myers.

The winner of the 100m. was B. Sheppard from P. Hampshire and D. Morters in 11.4.

Measuring an increase in fitness levels of umpires as a group can be extremely difficult as 1990 umpires numbers were on the increase, resulting in some people turning up for their first training session about three weeks prior to the grand finals.

Comparing average 4km time trials is about the best method available at present.

The most pleasing aspect of the season was the overall increase in the fitness level of umpires as indicated in 4km times. The biggest improvers were D. Galloway, K. Ray, L. Burnett, A. Gibson, S. Arnott, G. Godfrey, D. Levens, M. Rendell, P. Rowan, S. Wallbank and C. Dimolianis.

Winners of the training awards for 1990 were F. Kalayzich (Field), P. Hampshire (Boundary) and D. Galloway (Goal).
