# PRESIDENT'S REPORT Anton Lewis

It is with great pleasure that I present my second President's report, covering the 2008 season.

The 2008 season was a challenging year for the Association. We had a bit on our plate with a number of Committee positions having to be filled prior to the elected occupants even starting their roles. We found some suitable replacements for these positions but this meant a greater load being carried by a few for a period of time. Discussions around the CBA also commenced in 2008 and did not go as well as what we would have liked. Our relationship with the League and sharing of information seems to have improved in most areas. We now have a number of processes and channels embedded to further assist umpiring and the communication with the Association. We will continue to work with the League to ensure our Members obtain relevant information in a timely manner and we are able to resolve any issues that may arise amicably as happened in 2008.

2008 also saw improve training standards with our new coach Michael Hetherington taking us to greater levels of fitness. Michael will be with us again in 2009, so start training now!!

Graham Glassford continued in his role as coach of the AFL Sydney Umpiring Group as well as being the State Umpiring Manager for the NSW/ACT AFL.

This season our Association was represented by a boundary and goal umpire at the AFL level. Congratulations to these Members, and long may you represent NSW umpiring at this, the highest level. The opportunities clearly exist in a smaller football state for those who set their sights on them. The dedication and commitment required to reach this level is worthwhile once you step onto the ground for your first AFL game. It is good to see that Matthew Gestier has been provided with an opportunity to trial as a field umpire along with 10 others from interstate, so we wish him the best in his trial process.

Once again the Association explored a significant number of avenues regarding sponsorship. We were very fortunate to retain dd(too) and Columbia Coffee (Peter Nilson) as our sponsors. We welcomed USN as our major sponsor during the year. Challenges exist in this area in these financial times, and is something that we must all be vigilant about. The 2009 Committee will need to work hard and early to identify sponsors for 2009. Whether these be goods in kind or some dollars, please let a Committee person know as every bit helps and improves the services to all.

Membership numbers have grown this year, up from 68 in 2007 to the magical 71 mark in 2008. This is a welcome development, and all umpires should take credit for contributing to the harmonious and welcoming atmosphere at training. I encourage you to rejoin the Association in 2009 and continue this trend. The Association plays an important role in maintaining and developing the culture of the Sydney AFL group. We appreciate the feedback provided by our Members and hope that the initiatives we have started in 2007 & 2008 are of benefit to all.

The Committee has again attempted to make sure that a number of suitable and enjoyable social functions occurred to meet the needs of Members. Planning and scheduling these occasions continues to be a challenge and although a variety of events were organised across the various locals in Sydney they may not have suited all Members. Any suggestions regarding these functions are always welcome and we will plan accordingly to meets Members needs.

I would also like to thank the 2008 Committee for their hard work this year. Each Committee Member has contributed in their own way to help make this season a successful one. We are losing some Members for various reasons and I'm sure that their boots will be hard to fill. The role of the Committee is not easy one. The bar that has been set has been high over the last few years with lots of expectations to meet. I'm sure whoever nominates and is elected onto the 2009 Committee positions will do as good a job as the previous incumbents.

I hope the 2009 season is beneficial to you all and I look forward to seeing you at the 2008 AGM.



### VICE PRESIDENT'S REPORT Angus Heritage

The 2008 season has been a long and demanding one but one which has also brought the NSWAFUA Committee and its Members more opportunities, great enjoyment, personal satisfaction and of course fun, laughter and a lot of cherished memories.

The Committee began working toward the 2008 season straight after the 2007 AGM and I have been both proud and honoured to serve the Members of the NSWAFUA as its Vice President for 2008.

The main objective of the Committee for 2008 was simple – to make the involvement and Membership of the NSWAFUA as rewarding, long lasting and satisfying as possible.

With this objective driving our strategy and planning we set about creating a business plan which included clearly articulated objectives, quantifiable results and related action plans – we later put this to the NSWAFUA Membership for confirmation and support.

We also delegated particular responsibilities to particular people; with the objective being that if people are responsible for something then the facilitation and execution of the function will not be left to the usual two or three people who have historically driven a number of the NSWAFUA activities.

There was an obvious need of securing sponsorship, reviewing current policies and processes and the use of available facilities and the range of services already offered – and how we could improve all these areas in a cost effective way.

We also began preparing for the larger issues of the CBA negotiations, umpire retention and welfare and reviewed the ways we represent ourselves (as an umpiring group) to both the AFL community and the broader general public.

In the role of Vice President, I was delegated responsibility for sponsorship and general business planning and worked closely with Richo (Sean Richardson) and Rowdy (Troy Edwards) in the areas of logistics with a primary focus on feeding, watering and general supplies for the 2008 running group.

I personally learnt a lot about the challenges of securing relevant and long term sponsors – which is not easy at the best of times, and these are not the best of financial times.

I believe a large number of new innovations introduced in the 2008 season have improved the services available to NSWAFUA Members including (but not limited to):

• The introduction of a formalised "buddy" system for new umpires to the group.

• The development of tiered Membership packages with various inclusions and value levels, which encouraged and enabled a larger number of people to become NSWAFUA Members in 2008 compared to previous years.

• The commitment of Jeff Milne (as one Committee Member) responsible for all NSWAFUA Member's welfare and on-going support.

• The introduction of more professional game day and training uniforms – which have increased the positive profile of our group to the broader community and made us look more professional.

The updating and implementation of the new NSWAFUA website to be both more interactive and user friendly but also a great resource for prospective future umpires.

· The securing of a dedicated website - www.umpireafl.com.au

• Increased interaction and involvement with other AFL representative bodies throughout NSW and Australia. In particular, the involvement of the NSWAFUA Members in the Junior Carnival was a great success both for the spirit of umpiring and financial for our Members – thank you again for those who assisted over that weekend.

• Better use of the resources that "The Reg" has to offer and in particular the more regular and more diverse food and product offering – particularly for the Thursday Feeds. Thank you, also to all those who have assisted with the preparation and delivery of food throughout the season – I know that a lot of work goes on behind the scenes.

• The increased focus on ensuring the social and fundraising activities are both relevant, fun and profitable – not always an easy mix to get right.

· Increased levels of communication and information provided to Members regularly.

### SECRETARY'S REPORT Sean Richardson

The NSWAFUA is the heart and soul of umpiring in the Sydney. Our single most important task is creating a friendly, supportive and engaging environment for umpires, especially our Members. The importance of this role for umpire recruitment and retention cannot be underestimated. To this end, I believe that the Committee has continued to 'raise the bar' in season 2008 - however much work remains ahead.

An enduring challenge for the NSWAFUA, the AFL Sydney Umpiring Department and the AFL NSW/ACT is defining the differing roles and responsibilities of each organisation. There is often confusion (and somewhat differing expectations) surrounding our respective duties and responsibilities amongst League Officials, Coaching Staff and the Association. This year the Committee has attempted to clarify matters through our Umpiring Handbook Supplement, our Welcome Brochure, regular Member updates and in our CBA negotiations. This remains an ongoing issue for all parties to ensure we all continue to operate from the same perspective.

We achieved our target of 71 Members for the 2008 season, an increase from 66 in the previous year. Achieving a 100% sign up rate from those umpires who 'regularly' attend training was a further goal of the Committee, but one that once again went unrealised.

The appointment of Carl Fletcher as Umpiring Development Officer this season was a fantastic step forward for umpiring in both Sydney and NSW. This has seen futher focus and resources placed into junior umpiring programs across the state, including the Regional Squad and Development Academy. Nonetheless, there still remains somewhat of a 'gap' between the junior and senior umpiring groups in Sydney, which the NSWAFUA can look to help 'bridge'. We took some stall steps forward with our involvement in the AFL GSJ Representative Carnival and invitations to our Annual Ten Pin Bowling Challenge, which will provide a further platform linkages in 2009.

The CBA negotiations throughout the season have proved tiring and often challenging. The NSWAFUA has attempted to take a holistic approach to both the process and the new Agreement. We have had extensive consultation with Members who have supported a wider view to the conditions support structures provided to the Association and Members - rather than simply fee increases. At seasons end an Agreement for 2009 appears far from being reached. The support and resolve of Members in this process has been outstanding, and will continue to be needed as negotiations continue into the new season.

The 2008 Committee has worked tirelessly from early December last year to serve the Membership base. As much as I dislike the term as a core value, ensuring our work remains 'relevant' to Members is the guiding principle behind all Committee affairs.

Both Carl Fletcher and Michael Peck originally nominated for the Committee but were unable to continue in their roles due to changed work and university commitments. I thank them both for their service on the Committee in preceding years and hope they are able to renominate in future years.

Jeff Mile and Andrew Scovell were appointed to fill the casual vacancies and have done a sterling job. In only his first year on the Committee, Angus Heritage has shown outstanding leadership and dedication as Vice President, and Anton Lewis has continued his often unsung 'work horse' role as President.

Andrew Rutherford and Troy Edwards have both chosen not to nominate for the Committee in 2009, due to work commitments and intrastate relocation respectively. After recently announcing his engagement, Troy is moving up to the Central Coast - look out NCCUA! Both have performed diligently and admirably this season and I wish them both all the best in the future.

It is with much sadness that I have chosen not to nominate for the Committee next year. With a number of exciting personal matters on the horizon in 2009, I must 'step back' for the time being. It has been an honour serving as Secretary for the past two seasons and as an Ordinary Member in the preceding years.

Involvement with the Committee can often be a time consuming experience, but it is certainly a rewarding one. To my colleagues in 2008, I thank each and every one of you for your energy, passion, committment, patience and warped sense of humour. If it wasn't fun, it wouldn't be worthwhile! I wish the 2009 Secretary and Committee every success, and I encourage each and every Member to support their tireless work through your engaged and meaningful Association Membership. Something as simple as RSVPing to a function, reading a Member Update or attending an Association Meeting can often mean the world of difference.

After all - it's 'your voice, your team, your mates' - and your Association.



### TREASURER'S REPORT Sean Richardson

The Committee took a prudent approach to our financial affairs in 2008, after failing to attract a major sponsor this season. After a review of our financial situation at the start of the season we aimed to 'break even' over the course of the season, with a focus on attracting and retaining Members through affordable Association Membership and services. We also commenced maintaining the Association accounts and database through MYOB software, which allowed greater reporting functionality and insight.

Despite not securing a monetary sponsor, a number of non financial supporters offered goods and/or services in kind over the course of the season, and we extend them our sincerest thanks:

Bohemia Crystal (and Angus Heritage) Intercontinental Hotel (and Adam McDonald) dd(too) (and Sean Richardson) Columbia Coffee (and Peter Nilson) Sydney Water (and Jeff Milne) Oce Printing (and Paul O'Loughlin) USN - Ultimate Sports Nutrition

The support of such organisations is invaluable, and have allowed us to reduce/minimise costs and raise much needed funds. A further thank you to those Members who have facilitated these donations.

Membership Fees were once again 'tiered' through a range of different packages designed to accommodate our diverse group. This has been a very successful initiative over the past three seasons offering choice and flexibility to all Members. Dues were pegged at comparable 2007 levels, with only minor adjustments made based on slightly different inclusions. Bronze (or basic) level Membership remained at only \$60.

Members were very receptive to our investment in branded tracksuits in 2007, and accordingly all Memberships this year received a Member Pack (with inclusions, depending on your package, of a polo shirt, training shirt, bag, key ring, water bottle, towel, cap and sweatbands). This introduced an even greater level of professionalism to the group - after all, 'team that looks like a team, plays like a team'.

Thanks to the initiative of Paul O'Loughlin, the Association was able to provide canteen services to the AFL GSJ Representative Carnival held at Mahooney Park over the long weekend. Whilst a logistic nightmare to organise (and run) given the weather, facilities our limited experience (!), this nonetheless provided a much welcomed financial injection mid season. A number of intangible benefits also flowed through our support of junior football, promotion of umpiring and interaction with the junior umpires present. If continued in 2009 (and with better weather and the new canteen building) this fantastic initiative will prove even greater opportunities to the Association Our sincerest thanks to Paul O'Loughlin for his work securing the rights for the weekend, to Troy Edwards and the rest of the Committee for their work organising the canteen, and to those Members who helped serve over the three days.

Once again we ran our annual Cadbury chocolate drive, magnificently organised and executed by the wonderful Alison Stevens. Thanks to Alison's hard work this ran extremely smoothly - although I must confess to having three quarters of a box of snakes still sitting at home, uneaten!

A challenge that the Association has historically faced is budgeting for our two major end of season functions (President's Night and Presentation Night). With our fee income largely received up front and our expenditure deferred to later in the year, it is easy to succumb to a false sense of security regarding the financial state of affairs. The Committee attempted to account for these upcoming liabilities with a provision in the Treasurer's Report provided at Meetings throughout the season. Whilst somewhat conservative, we hope that this has provided a more realistic insight into the financial affairs and problems faced by the Committee.

Another feature of the Association accounts is that we only account for 'Members Funds' in our Statement of Financial Position (or Balance Sheet). All stock and inventory is immediately expensed to ensure only our liquid (cash) assets are represented. As such, the NSWAFUA recorded an approximate \$1000 financial loss for the 2008 season. Given the Committee's goal to break even this season, this loss is not unexpected and can be directly attributed to our significantly increased list of non financial items - primarily inventory. With a net realisable value in excess of \$3000, this represents deferred income for season 2009.

I will be stepping down as Treasurer at the end of this year (see Secretary's Report). I wish the incoming Treasurer (and Committee) every success in season 2009.



### COACH'S REPORT Graham Glassford

When reflecting on the season past and the umpiring group I need to reflect on twelve months. With preseason starting at the end of October and the dedication of a number of umpires now training close to the full year I can only be pleased in the turn around of the umpiring group as a whole.

The performances of all umpires across the season was very good and although we always face our challenges of never being able to satisfy our customers (the clubs) I believe our professional approach towards the game means we are respected by most. The culture of any group plays a very important role for any group and the Sydney AFL Umpiring Group is no different. While we are on the way to creating an environment that people want to belong to we still have some work to do to ensure a positive future for the group.

This year we improved the number of coaching staff and while we still struggle to view every umpire officiate throughout the year we are moving in the right direction. There is no doubt that each and every umpire wants improved feedback from the coaches. This is always a challenge given the limited resources however I believe that all of the coaches are accessable and willing to help each umpire achieve their goal. My sincere thanks to the following coaches for all of their hard work and dedication:-

There are a total of 58 field umpires, 24 boundary and 13 goal umpires that are on the list for the Sydney AFL Umpiring Group. The list size for 2008 has grown from 45 field umpires in 2007. The challenge is always to have all umpires officiating each week however that is not always possible with injury, work and family commitments being issues the umpiring group confronts. It is ever pleasing to have near on half the field umpiring panel aged between 18 and 25. Numbers of umpires attending training continues to increase which is encouraging.

The finals series saw the introduction of MatchComs for the Senior field Umpires. This proved to be a valuable coaching tool for the umpires involved but also for the coaches. It was pleasing to note that the umpires communication with players was externely professional and something that the whole group could be very proud of. It is hoped that the system can be continued in some form or another in 2009.

Shrinkage in the number of goal umpires this year is a concern and in the off season a concerted recruitment effort will be implemented by the Umpiring Department to try and boost numbers.

The Umpiring Department continues to work closely with the Greater Sydney Junior Umpiring groups to ensure that umpires who wish to progress from beyond junior football are given every opportunity. A major role of the Umpire Development Officer has been to work closely and promote umpiring as a real alternative. There is no doubt that program's such as the Sydney Umpiring Regional Squad and the NSW/ ACT Development Academy are important pieces in developing umpires throughout the region.

This year we also trialed a School Based Academy program in partnership with Endeavour Sports High School. This was a weekly program conducted within the school to train students in umpiring Australian Football. Students within various sports including athletics, oztag and of course football were given the opportunity around the middle of the year to be a 'Green Shirt Umpire' running the boundary in the Sydney AFL. The relative success in this pilot will see the potential for a number of schools to be involved in 2009.

A number of umpires in the group were appointed to games outside the Sydney AFL as part of their umpire pathway development. Congratulations to those umpires.

It is also pleasing to be able to announce that Matthew Gestier has been selected to trial as a Field Umpire for the AFL. Matthew becomes the first AFL Field Umpire to trial in NSW/ACT that has come entirely through the NSW/ACT system. This achievement will only help other aspiring umpires to believe that Sydney AFL is a viable competition to gain entry to the AFL.

In 2008 four umpires were part of the AFL Umpiring Panel, Adam McDonald, Luke McSpeerin (Boundary), Segio Villagra (Goal) and Mathew James (Field) who moved to Sydney midway through the season.

The Umpiring Department continues to work hard at building the base of umpires to ensure it caters for the growth of the game at all levels. By engaing the junior groups and the introduction of recruitment programs like School Based Academies we are building the base of umpires that over the next few years will translate into a greater increase in the number of senior umpires in the Sydney AFL competition.
